

Copy of board Proceedings of the Special meeting of the Cantonment Board Cannanore held on 01-02-2018 at 11.00 hours in the conference hall of the Cantonment Board Cannanore.

Agenda No.1.

To discuss regarding the alignment of (1) footpath passing through the survey No.57 land clarification 'C' (2) A lane passing through survey No.60/B of land clarification 'C' based on the request of board members to give land for the footpath and lane for the public access of Cantonment Board bus stand by the public of the Kannur Corporation.

Resolution No.1 : Board discussed the matter in detail and unanimously decided to

(1) To allow a footpath on GLR SY No.57 along the boundary of the church with a width of 5 feet, for the public of the Kannur Corporation to reach Cantonment Board bus stand.

(2) To allow a lane on GLR Sy No.60-B leaving 4.5 meter from the boundary pillars No.90 to 99 for the public of the Kannur Corporation as the right of way and access to their houses.

(3) In GLR SY No.57 land in which footpath is allowed will be kept temporarily open until the provision of land in lieu given by State Government. Footpath is only for the pedestrian use and steps will be made at the openings on the both the ends to restrict the movement of vehicle.

(4) In GLR Sy. No.60/B the land in which lane is allowed will be kept temporarily open until the provision of land in lieu is given by the state Govt.

(5) Board decided to initiate a proposal with the state Government for equal value land after assessing the land lost and an agenda point will be made in the next board meeting.

(6) As a temporary measure fencing will be made with iron rods and barbed wire. Estimates for constructing compound wall will be put before the board on the next board meeting.
